## **JAMES SCICLUNA - WH PARTNERS**

James Scicluna is a Maltese Advocate and a Solicitor of the Senior Court of England and Wales. James provides advice mainly to the Gaming, Financial Services, Real Estate and Hospitality industries. After being awarded the Chevening Scholarship by the British Foreign and Commonwealth Office in 2004, he graduated with an LLM Summa Cum Laude in International Business Law from University College London. He holds a Doctor of Law and a B.A. in Law & Sociology from the University of Malta. James ranks as one of the top 50 gaming & gambling lawyers by Chambers & Partners. He also lectures Gaming Law at the University of Malta.



## **MICHAEL PSAILA – MAMO TCV**

Michael Psaila graduated Doctor of Laws from the University of Malta in 2004 after submitting a doctoral thesis entitled 'The Raising and Maintenance of Capital'. He furthered his studies at King's College London, where he obtained a Masters of Law degree in Corporate and Commercial Law. Michael was called to the bar in January 2005 and was a partner at Simon Tortell & Associates since the firm was founded in May 2009 until it merged with Mamo TCV in July 2016. Michael's main areas of practice include banking and finance, capital markets, corporate and insolvency law. He is a member of the Chamber of Advocates, the Institute of Financial Services Practitioners and the International Bar Association and is also recommended in most major legal directories.
